十、 註冊安排：

1. **正選生**：家長須於 2024 年 1 月 4-6 日的指定時間到本幼稚園辦理註冊手續，並須提交「註冊證」/「入學許可書」及繳交註冊費。
2. **備取生**：本幼稚園會發出電郵通知，請家長於指定日期到本幼稚園辦理註冊手續，並須提交「註冊證」/「入學許可書」及繳交註冊費。
3. 如未能在指定的註冊日期提交「註冊證」/「入學許可書」，本幼稚園或未能為獲取錄兒童完成手續，因此家長務必於指定日期內向教育局申請相關註冊文件。
4. 2024/25 學年的註冊費為港幣 1,570 元正。如有關兒童入讀本校，本校會於 2024 年 8 月退回註冊費，但若家長於註冊後決定為子女轉校，請以書面通知本幼稚園，但註冊費將不獲退還。在取回「註冊證」/「入學許可書」後，本幼稚園亦不會再為該兒童保留學位。

A. Eligibility

K1 : for children born between October 2020 - December 2021

K2 : for children born between October 2019 - December 2020

K3 : for children born between October 2018 - December 2019

Children who apply for K1-K3 admission must be born on or before the appointed date, otherwise the application would not be considered.

B. Submission Period

1st to 28th September 2023 (10:00am to 5:00pm) and 29th September 2023 (9:00am to 3:00pm)

C. Submission of Application

1. Please fill out the online application form, upload a passport size photo, a birth certificate through the online application system.
2. Please be ensured that the email address of "noreply@smtp.kllck.edu.hk" have been added to your safety list in order to prevent our confirmation email to be filtered as junk email.
3. Filling out all required fields is mandatory for the application.

HK\$40 (Online payment, non-returnable whether the application is successful or not.)

F. Admission Criteria

1. Interview performance
2. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration.
3. The applicant from families in need will be given due priority consideration. (As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)





G. Evaluation Arrangements

1. The kindergarten will evaluate all applicants.
2. Evaluation will be conducted on November, 2023, detail will inform by email.

I. Announcement of Admission Results

We will inform parents of the admission results on 6-8 December 2023 by e-mail.

J. Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child at 4th to 6th January 2024 ("Centralized Registration Dates") and paying the registration fee.
2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school email. Parents are required to pay the registration fee.
3. Please be reminded that if parents cannot submit the RC / AP during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to the EDB within the specified period.
4. The registration fee for 2024/25 place is HK\$1,570. The Kindergarten will refund the registration fee on August 2024 if the child studies in our school. Should parents decide to change school after registration, please notify the kindergarten in writing. The registration fee will not be refunded.

K. Remarks

1. If translation service is needed for non-Chinese speaking applicants, please contact the school in advance so that the school can arrange interpreters for the interview. Chinese-speaking family members or friends are welcome to accompany the applicants during the interview for translation.
2. The kindergarten is join the Kindergarten Education Scheme. The kindergarten will handle admissions under the "Admission Arrangement provide by EDB for the 2024/25 School Year".
