- 2. 請將"noreply@smtp. kllck. edu. hk"加到你的安全電郵通訊錄地址名單內,以免電郵系統錯誤刪除「確認電郵」,或郵件可能被分類到雜件箱內,敬請留意。
- 3. 請填寫所有資料,以便完成整個報名手續。

#### 七、 評核安排:

- 1. 本幼稚園會安排所有申請入讀的兒童進行評核
- 2. 評核日期於 2024年11月進行,詳情本幼稚園會另函通知家長。

## 十、 註册安排:

#### 1. 正選生:

**幼班**—家長須於 2025 年 1 月 2-4 日的指定時間到本幼稚園辦理註册手續,並須提交「註冊證」/「入學許可書」及繳交註冊費。

高、低班—家長須於指定日期帶同「臨時註冊信」到本園辦理註冊手續並提交註冊費。請注意,如以「臨時註冊信」辦理註冊手續,家長必須於其子女入讀本園首天或之前,向本園提交其子女的有效「註冊證」/「入學許可書」才可讓有關學童入讀。如首次在香港申請入讀低班或高班幼稚園之插班學生,家長須為其子女向教育局申請「註冊証」。家長可在教育局網頁查看申請詳情。

- 2. **備取生:**本幼稚園會發出電郵通知,請家長於指定日期到本幼稚園辦理註冊手續,並 須提交「註冊證」/「入學許可書」及繳交註冊費。
- 3. 如未能在指定的註冊日期提交「註冊証」/「入學許可書」/「臨時註冊信」,本幼稚園或未能為獲取錄兒童完成手續,因此家長務必於指定日期內向教育局申請相關註冊文件。
- 4. 2025/26 學年的註冊費為港幣 1,570 元正。如有關兒童入讀本校,本校會於 2025 年 8 月退回註冊費,但若家長於註冊後決定為子女轉校,請以書面通知本幼稚園,但註冊費將不獲退還。在取回「註冊證」/「入學許可書」後,本幼稚園亦不會再為該兒童保留學位。

- 1. 非華語學童之面試,如需翻譯服務,可聯絡本校,以便校方作出相應安排。有關學 童亦可由懂得華語之家人或親友陪同面試,以便為其翻譯。

# Kowloon Ling Liang Church Day Nursery Application Guidelines of Year 2025/26



## A. Eligibility

K1: for children born between October 2021 - December 2022

K2: for children born between October 2020 - December 2021

K3: for children born between October 2019 - December 2020

Children who apply for K1-K3 admission must be born on or before the appointed date, otherwise the application would not be considered.

#### B. Submission Period

Started from September 2, 2024(10:00am), until all quota are filled.

## C. Submission of Application

- 1. Please fill out the online application form, upload a passport size photo, a birth certificate through the online application system.
- 2. Please be ensured that the email address of "noreply@smtp.kllck.edu.hk" have been added to your safety list in order to prevent our confirmation email to be filtered as junk email.
- 3. Filling out all required fields is mandatory for the application.

## D. Application fee

HK\$40 (Online payment, non-returnable whether the application is successful or not.)

#### F. Admission Criteria

- 1. Interview performance
- 2. The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration.
- 3. The applicant from families in need will be given due priority consideration. (As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)

## G. Evaluation Arrangements

1. The kindergarten will evaluate all applicants.

2. Evaluation will be conducted on November, 2024, detail will inform by smail.



### I. Announcement of Admission Results

We will inform parents of the admission results on 4-6 December 2024 by e-mail.

## J. Registration Arrangements

1. Successful applicants:

K1 Class-Parents should complete the registration procedures for their child at  $2^{th}$  to  $4^{th}$  January 2025 ("Centralized Registration Dates") and paying the registration fee.

K2&K3 Class-Students from K2 or K3 classes must apply for the Provisional Registration Letter (the letter) from the Education Bureau, and bring the letter to us on the specified date to complete the registration procedures and submit the registration fee. If this is the first time applying for admission to K2/K3 class kindergarten for a transfer student in Hong Kong, parents must apply for a "Registration Certificate" for their children from the Education Bureau. Parents can check the application details on the Education Bureau's website.

- 2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school email. Parents are required to pay the registration fee.
- 3. Please be reminded that if parents cannot submit the RC / AP during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to the EDB within the specified period.
- 4. The registration fee for 2025/26 place is HK\$1,570. The Kindergarten will refund the registration fee on August 2025 if the child studies in our school. Should parents decide to change school after registration, please notify the kindergarten in writing. The registration fee will not be refunded.

#### K. Remarks

- 1. If translation service is needed for non-Chinese speaking applicants, please contact the school in advance so that the school can arrange interpreters for the interview. Chinese-speaking family members or friends are welcome to accompany the applicants during the interview for translation.
- 2. The kindergarten is join the Kindergarten Education Scheme. The kindergarten will handle admissions under the "Admission Arrangement provide by EDB for the 2025/26 School Year".
